

CAMPSPOT "RV REVIVAL FUND" GIVEAWAY OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. SEE THE ALTERNATIVE METHOD OF ENTRY DESCRIBED IN SECTION 4 BELOW.

1. **SPONSOR:** This Campspot RV Revival Fund Giveaway ("Sweepstakes") is sponsored by RezPlot Systems, LLC d/b/a Campspot, 38 Commerce Ave. SW, Suite 200, Grand Rapids, MI 49503 ("Sponsor").
2. **WHO IS ELIGIBLE:** All entrants must be at least eighteen (18) years of age at the time of entry and the age of majority in their jurisdiction of residence at the time of entry. The Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia, excluding residents of Puerto Rico, all U.S. territories and possessions, and all overseas military installations, and is void where prohibited by law. Employees, independent contractors, interns, officers, directors, and agents of the Sponsor, their respective affiliates, subsidiaries, advertising and promotion agencies and suppliers (collectively, the "**Sweepstakes Entities**") and their immediate family members and/or those living in the same household (whether legally related or not) are not eligible to participate in the Sweepstakes. For the purpose of the Sweepstakes, family members are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Limit one (1) eligible entry per person during the Entry Period (defined below). Entries that are incomplete, illegible, corrupted, false, lost, late or misdirected, deceptive, or otherwise not in compliance with the Official Rules (defined below) may be disqualified from the Sweepstakes at the Sponsor's sole and absolute discretion. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to the Sponsor's satisfaction, the affected entry will be deemed ineligible. Illegible and/or incomplete entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.
3. **ENTRY PERIOD:** The Sweepstakes begins on July 14, 2026 at 12:00 AM EDT and ends on July 28, 2026 at 11:59 PM EDT (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible.
4. **HOW TO ENTER:** Eligible entrants who complete a qualifying RV trip booking on Campspot during the Entry Period will automatically receive one (1) entry into the Sweepstakes. As an alternative method of entry ("AMOE"), eligible entrants may send a handwritten letter to Sponsor with their name, address, date of birth, email address, phone number, and the words "RV Revival Fund Entry" to Campspot, 38 Commerce Ave. SW, Suite 200, Grand Rapids, MI 49503. AMOE entries must be postmarked during the Entry Period and received within seven (7) days thereafter. Limit one (1) eligible entry per person during the Entry Period, regardless of method of entry. An eligible entrant may also invite one (1) additional eligible camper (the "Invited Camper") by forwarding the designated campaign email or using the invitation link provided by Sponsor. To qualify for the additional prize described below, the Invited Camper must complete all required steps during the Entry Period, including submitting the required form information, downloading the Campspot app, and providing the email address associated with the original entrant's Campspot account so Sponsor may match the Invited Camper to the original entrant's eligible entry. Only one (1) Invited Camper may be matched to each eligible entry. Entries that are incomplete or do not adhere to the rules or specifications of the Sweepstakes may be disqualified at the sole discretion of the Sponsor. Entrants may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If an entrant uses fraudulent methods or otherwise attempts to circumvent the rules of the Sweepstakes, the submission may be disqualified at the sole discretion of the Sponsor. Entry information may be shared with prize providers.
5. **WINNER SELECTION / NOTIFICATION:** One (1) winner will be selected by random draw under the supervision of the Sponsor on or about July 31, 2026 from all eligible entries received during the Entry Period. The potential winner will be notified within seven (7) days of winner selection using the contact information associated with the winning entry. If a valid Invited Camper was properly matched to the winning entry and completed all required steps during the Entry Period, the Invited Camper will also be eligible to receive the additional prize described below. The Sponsor shall have no liability for a winner's failure to receive notices due to spam, junk e-mail or other security settings or for a winner's provision of incorrect or otherwise non-functioning contact information. If the winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed affidavit of acceptance, eligibility, liability,

and release (where legal), as well as a W-9 form, as required, within fourteen (14) days from the time of award notification, then the prize may be forfeited and an alternate winner selected. Receipt of the prize offered in this Sweepstakes by the winner is conditioned upon compliance with any and all federal, state, and local laws and regulations. Any violation of these Official Rules by the winner at the Sponsor's sole discretion will result in the winner's disqualification as winner, and all privileges as winner will be immediately terminated.

6. **PRIZE:** The winner of the Sweepstakes will receive one (1) \$3,000 digital Visa gift card. If the winning entry has a properly matched Invited Camper who completed all required steps during the Entry Period, the Invited Camper will receive one (1) additional \$3,000 digital Visa gift card. The specifics of the prize shall be solely determined by the Sponsor and/or the prize provider. No cash or other prize substitution shall be permitted except at the Sponsor's discretion. The prize is non-transferable. Substitution of the prize or transfer/assignment of the prize to others or request for the cash equivalent of the prize by the winner is not permitted. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the prize recipient. The Sponsor and/or prize provider will issue an IRS Form 1099 tax form in the amount of the prize retail value as stated herein to any recipient that receives a prize with retail value of \$600 or more. A winner's or Invited Camper's address may be shared with prize providers to enable prize fulfillment. Acceptance of the prize constitutes permission for the Sponsor to use the winner's and, if applicable, the Invited Camper's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
7. **BINDING AGREEMENT:** In order to participate in the Sweepstakes or to win a prize, entrants must agree to these Official Rules ("**Official Rules**"). Because these Official Rules form a legally binding agreement with respect to the Sweepstakes, please read them carefully. If an entrant does not agree to the Official Rules, the entrant is not eligible to participate in the Sweepstakes or to win a prize. Each entrant agrees that their registration as an individual participant under the Sweepstakes constitutes their agreement to these Official Rules, and each entrant represents and warrants that they meet the eligibility requirements. Each entrant agrees to accept the Sponsor's decisions as final and binding as it relates to the content of this Sweepstakes. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes. The Sponsor reserves the right to permanently disqualify from any Sweepstakes it sponsors any person it believes has intentionally violated these Official Rules. Entrants should look solely to the Sponsor with any questions, comments or issues related to the Sweepstakes.
8. **ODDS:** Odds of winning a prize depend upon the total number of eligible entries received.
9. **WINNERS LIST:** To request a copy of the winners list, please contact the Sponsor. Requests must be sent within four (4) weeks of the end of the Entry Period.
10. **GENERAL CONDITIONS:** The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes should virus, bug, non-authorized human intervention, fraud, or other cause beyond the Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such cases, the Sponsor may select winner(s) from eligible entries received before and/or after the action taken by the Sponsor if appropriate. The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or App or violates these Official Rules. The Sponsor has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Sweepstakes rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or the App or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. Should such an attempt be made, the Sponsor reserves the right to seek damages to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **INDEMNIFICATION / RELEASE OF LIABILITY:** By entering into and participating in the Sweepstakes, each entrant agrees to release, discharge, indemnify, and hold harmless the Sweepstakes Entities from and against any and all claims, demands, liability, damages or causes of action (however named or described), losses, costs or expenses, with respect to or arising out of or related to: (i) entrant's participation in the Sweepstakes; (ii) entrant's acceptance, possession, use or misuse of a prize (including, without limitation, any liability, illness, loss, damage, personal injury, death, litigation or claim that may occur, directly or indirectly, whether caused by negligence or not); (iii) unauthorized human intervention in any part of the Sweepstakes; (iv) electronic or human

error in the administration of the Sweepstakes or the processing of entries; (v) technical errors of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (vi) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (vii) printing errors; and/or (viii) lost, late, misdirected, or undeliverable mail. A winner assumes all liability for any injury or damage caused, or claimed to be caused, by participation in this Sweepstakes or use or redemption of a prize.

Under no circumstances shall entrant be permitted to obtain awards for, and entrant hereby waives all rights to, punitive, incidental, and/or consequential damages, including reasonable attorney's fees, other than actual out-of-pocket expenses (i.e., costs associated with entering the Sweepstakes). Entrant further waives all rights to have damages multiplied or increased. Because some states do not allow the exclusion and/or limitation of liability for consequential or incidental damages, in such states, the Sponsor's liability is limited to the maximum extent permitted by law.

12. **NO WARRANTY:** ALL PRIZES ARE AWARDED "AS IS" AND WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE).

13. **GOVERNING LAW:** The Sweepstakes and these Official Rules are governed by and shall be construed in accordance with the laws of the State of Michigan, without regard to the principles of conflicts of laws. All disputes shall be resolved exclusively in the state or federal courts in the State of Michigan, and entrant expressly consents to the jurisdiction of said courts and waives any objection thereto. All applicable federal, state and local laws and regulations apply. By participating in this Sweepstakes, entrant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Sweepstakes, shall be resolved individually, without resort to any form of class action.
14. **ADDITIONAL RULES:** Entry data that has been tampered with or altered are void. No responsibility is assumed for: (i) lost, late, misdirected, damaged, garbled, incomplete or illegible entries, all of which are void; (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, mobile device, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry information by Sponsor on account of technical problems; or (iii) any injury or damage to entrant's or any other person's mobile device or computer related to or resulting from participating in the Sweepstakes. The date and time of entry receipt shall be determined by the official clock on the Sponsor's website. Submitted materials become the sole property of Sponsor and will not be acknowledged or returned. Sponsor reserves the right to suspend, modify or terminate the Sweepstakes if Sponsor believes, in its sole discretion, that malfunction, error, disruption or damage is impairing or will impair the administration, security, fairness, integrity or proper conduct of the Sweepstakes. If the Sweepstakes is terminated before the end date, Sponsor will determine the winner from all eligible entries received as of the termination date.

In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the Sponsor's website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control, and the discrepancy will be resolved in Sponsor's sole discretion. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained here.

ANY ATTEMPT TO DELIBERATELY DAMAGE THE SPONSOR'S WEBSITE OR APP OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEYS' FEES) TO THE FULLEST EXTENT OF THE LAW.

news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notice, review, or consent. If the entry infringes upon the intellectual property right of another, entrant will be disqualified at the sole discretion of the Sponsor. If the content of the entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, entrant shall, at their sole expense, defend or settle against such claims.
